10. Campus Representative Coordinator Report – Craig Gunn, Michigan State University

Not present, but he is at his cabin on Lake Michigan. Has talked to David Sanchez about getting an updated master list of all institutions in our Section.

11. Vice Chair Report - Andy Milks, University of Akron

Follow up from Fall 2022 Executive Board meeting Section will now be offering an Outstanding Teaching Award for Early Career (first 5 years). This is in addition to the

current Outstanding Teaching Award that qualifies the recipient to complete for the ASEE National Outstanding Teaching Award. Each Award will come with a plaque and cash award of \$400 from the Section.

Milks will coordinate applications dates with ASE Nationals website. Need to decide if applications will submit to ASEE Nationals website, or directly to Milks. Has been done both ways in the past. Milks will work with 2023 award winner to get their materials updated for submission for the 2024 National Outstanding Teaching Award review process.

15. Best Paper Awards Chair – Tony Kerzmann, University of Pittsburgh – not present – David Sanchez as sub

Tony in contact with WMU about review process for 2024 Section Conference. File of Best Paper from Spring 2023 Section Conference needs to be sent to the Zone 2 Chair. For Zone 2 Paper Review Committee process (held in Fall 2023, winner advances to June 2024 competition at ASEE Nationals). **Andy Milks will serve** as "NCS Awards Chair" for the Zone 2 review process.

Winners must be a member or student in NCS to win. Cash awards will be paid to one person if it is a team paper or poster, and they must figure out how to divide it up.

16. Web Master Report – Wook-Sung Yoo, Marshall University

Updating content on website can be done, Transitioning website to new software platform. GoDaddy.com as host, rather than a university server. Send updated materials to Wook-Sung Yoo. If anyone wishes to proofread website, please send any corrections that are identified.

Need to reimburse for web address. **Motion by Sanchez and seconded by Baine to reimburse.** Unanimously approved. Yoo needs to get receipt or bill to the Treasurer, Greg Harstine.

17. Chair Report – David Sanchez, University of Pittsburgh

Conference Request Letters have been received from Ohio Northern University (ONU) and Kettering University (KU), plus a letter from Gary Steffen (IL/IN Section) to host a joint NCS and IL/IN Section Conference.

Discussion ensued. Single host in 2027 and Joint Conference in 2028? Geography of Section and desire to move conference around, and review of locations of past few years. Contact ONU about hosting Joint with IL/IN as they are closer geographically than KU?

Motion by Betsy Aller and seconded by Nicholas Baine to accept ONU as host for 2027 NCS Section Conference. Unanimously approved. Sanchez will contact ONU about a possible Joint Conference with IL/IN, but it will be an ONU decision as to their preference.

Have had a Joint Conference with IL/IN in the past at Fort Wayne, IN. A Joint Zone 2 Conference was held at San Juan, Puerto Rico in June 2017. Not a lot of support in the discussion for a Joint Conference, as NCS is successful in having interest to host by individual institutions.

Motion by Betsy Aller and seconded by Carmen Cioc. Pending outcome of ONU decision on a possible Joint Conference in 2027, we would invite Kettering University for hosting in 2028. Unanimously approved.

18. Old Business and/or New Business

Old Business

Due to financial difficulties at ASEE Nationals, we have limited access to our "historic balance funds," which were all swept by ASEE Nationals to pay bills, with promise of return in the future. Next Treasurer report will update Section as to what we have access to.

New Business

a). Pursue industry sponsors for some NCS items? e.g., Newsletter, Student Paper Awards, etc. Acknowledge sponsors on website and in Newsletter. Would need to figure out an accounting mechanism.

Motion by Nicholas Baine and seconded by Andy Milks and David Dampier. NCS Executive Board members can have sponsorship discussions for Section events. Not official unless approved by NCS Executive Board. Unanimously approved.

b). Outstanding Teaching Award Honorable Mentions

Discussion ensued on recognizing very good applicants who were not selected.

Motion by Carmen Cioc and seconded by David Dampier. Decision on Honorable Mentions will be made at the discretion of the Vice Chair and the Review Committee. Acknowledge in Newsletter, at Section Conference, and on website. Unanimously approved.

- d). Award Plaques for Section Conference (Outstanding Teaching, Outstanding Campus Representative, Appreciation to Long Serving Executive Board members). Betsy Aller and Andy Kline have been getting these done for a number of years (and donating the cost), or does the conference host wish to do themselves? Consensus to continue with Aller and Kline. One less thing for conference host to worry about.
